Official Rules for Food Vendors—97th Annual Capay Valley Almond Festival

1. The 97th Annual Almond Festival, will be presented by Esparto Regional Chamber of Commerce, the "Chamber", in the Esparto Community Park, 17001 Yolo Ave, Esparto, CA 95627 on **Sunday, March, 11th 2012 from 8:00am to 5:00pm.**
2. **Vendor agrees** that, if accepted by the chamber for the 97th Annual Capay Valley Almond Festival, the Chamber is under no obligation to rent booth space to the Vendor in the future Festivals. Booth locations will be rented and assigned in accordance to date payment is received and availability and the best interest of the festival, which the Chamber at its sole discretion shall have the rights to decide. To occupy booth space as assigned, and to be open and staffed during all regular festival hours 8am-5pm on Sunday, March 11th 2012 and to be completely set-up by 8am and vehicles removed from the area by 7:15am. Absolutely NO VEHICLES will be permitted around or near the park area after 7:15 am the morning of the event. to allow the Chamber to use their photos and application materials for promotional purposes. to obtain written permission from the Chamber prior to using the Esparto Regional Chamber logo, Almond Festival logo, or any photos/art from the Esparto Regional Chamber of Commerce website in connection with the business.
3. **Only menu items authorized by the Chamber will be allowed for sale at the Festival.** Any Vendors found selling unauthorized items will be asked to vacate his/her booth space immediately and shall do so with no refund of booth fees.
4. **It is the sole obligation of the chamber to furnish an outdoor booth space.** There are no refunds, rain checks or extended show dates due to inclement weather. The Chamber is not obligated to provide other services of any nature.
5. **Vendor shall be liable** for delivery, handling erection or removal of his/her own displays and equipment. All displays, equipment, merchandise and supplies must be contained within the assigned booth space. Electricity is not available. Only whisper quiet generators are allowed and must be indicated on your application. The grounds must be cleaned and returned to it's original state in and around your booth by **6:30 p.m.**
6. **Insurance,** must be supplied by the vendor stating **Esparto Regional Chamber of Commerce is listed as Additional Insured with limits of \$1,000,000 for Annual Capay Valley Almond Festival, an event at Esparto Community Park on March 11th, 2012**(Must have this text stated on it) and be obtained at the Vendor's own expense. The Chamber assumes no risk and, by acceptance of this agreement, the Vendor expressly releases the Chamber and all of its representatives of and from any and all liability for any damage, injury or loss to any person or goods which may arise from the rental and occupation of said booth space by Vendor, and agrees to hold and save the Chamber and its representatives harmless of any loss or damage by reason thereof. 7. **The Chamber will not be liable** for refunds or any other liabilities whatsoever for the failure to fulfill this contract due to acts of God, public enemy, strikes, statutes, ordinances or any legal authority, or any other cause beyond the Chamber's control.
8. **All pertinent Fire Codes, laws, ordinances and regulations** pertaining to health, fire prevention and public safety shall be strictly obeyed. Nothing shall be nailed, stapled, taped or otherwise fixed to any community or private property.
9. **Vendor will be required** to have any & all business licenses, permits & requisite needed to operate his/her operation.
10. **Health Permits:** Vendor is solely responsible for meeting all Health Department Requirements. And obtaining all permits. Packaged Food Vendors are also required to obtain a Health Dept permit. Call the Yolo County Environmental Health Department(530)666-8646 and provide copies of these permits along with application. www.yolocounty.org
11. **Payment Terms:** Applicants must submit a check or money order reflecting the appropriate booth fees including the application/contract, required documentation and permits for booth space. Applications received without payment will not be considered. Checks will be deposited upon receipt. Jury notification will be by **February 15, 2012.** Rejected applicants will receive a 100% refund of booth fees with notice of rejection.
12. **Cancellation Policy:** Booth Fees are non-refundable, absolutely no refunds will be given. This is a RAIN or SHINE event and there will be no exceptions.
13. **This Contract:** constitutes the entire contract between parties & no waivers, modifications /amendments shall be valid unless written upon or attached hereto & shall be approved in writing by Esparto Regional Chamber of Commerce.
